Information notice on the processing of personal data pursuant to Article 13 of Regulation (EU) No. 2016/679

Pursuant to and for the purposes of Article 13 of Regulation (EU) No. 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data, as well as on the free movement of such data, repealing Directive 95/46/EC, also known as the General Data Protection Regulation (hereinafter "GDPR"), we inform you that the personal data voluntarily provided by you to Fiere Internazionali di Bologna – BolognaFiere S.p.A. (hereinafter also the "Company" or "BolognaFiere") will be processed in compliance with the applicable legislation on personal data protection.

1. Data Controller and Data Protection Officer

The Data Controller is BolognaFiere, represented by the Chairman pro tempore, with registered office in Bologna, Viale della Fiera no. 20.

The Data Protection Officer can be contacted at the following email address: dpo@bolognafiere.it for any matters concerning the processing of personal data.

2. Purposes of processing and legal basis of processing

Your personal data will be processed for the following purposes:

a) establishment and performance of the contractual relationship between you and BolognaFiere (e.g. ticket sales, rental of exhibition space, organization of events – including online events – in which you are interested in participating, provision of ancillary services related to your participation, planning of services requested by you, publication of exhibitors' data in the event catalogue, etc.).

With reference to this purpose, the legal basis for processing consists in the performance of contractual or pre-contractual obligations relating to a contract to which you are a party. Any refusal to provide the data will make it impossible for BolognaFiere to provide the requested services. Please note that any processing of special categories of personal data will be carried out exclusively where such data are communicated or made public directly by you. Such processing will be lawful pursuant to Article 9(2)(e) of the Regulation. The provision of such data is not mandatory;

b) compliance with all legal, fiscal and administrative obligations imposed on BolognaFiere. With reference to this purpose, the legal basis for processing consists in compliance with legal obligations imposed on BolognaFiere. Any refusal to provide the data would make it impossible for BolognaFiere to provide the requested services;

c) preparation of statistical studies and market research. With reference to this purpose, the legal basis for processing consists in your specific consent, in the absence of which BolognaFiere will not be able to carry out market research involving your data. In any case, you will still be able to use the services offered by BolognaFiere;

d) performance of profiling activities aimed at understanding your possible needs in relation to the offer of new services based on the preferences expressed. With reference to this purpose, the legal basis for processing consists in your specific consent, in

the absence of which BolognaFiere will not be able to use your data for profiling purposes. In any case, you will still be able to use the services offered by BolognaFiere;

e) performance of commercial and marketing activities related to BolognaFiere's activities by post, internet, telephone, email, SMS, MMS, from Italy or abroad. With reference to this purpose, the legal basis for processing consists in your specific consent, in the absence of which BolognaFiere will not be able to carry out such commercial activities. In any case, you will still be able to use the services offered by BolognaFiere;

f) transfer of your data to other companies of the BolognaFiere Group and to third parties such as exhibition organizers and partners involved in the organization of individual trade fairs, including those based in non-EU countries, in order to allow them to carry out independent marketing initiatives relating to their own products and services. With reference to this purpose, the legal basis for processing consists in your specific consent, in the absence of which BolognaFiere will not be able to transfer your data to third parties. In any case, you will still be able to use the services offered by BolognaFiere;

g) enabling BolognaFiere to carry out video recordings and/or photographs during exhibitions and events for publication on our websites/landing pages and social media profiles (e.g. Twitter, Facebook, YouTube, etc.) and on brochures, catalogues, flyers and other printed or promotional materials related to the event.

The legal basis for processing consists in the legitimate interest of the Data Controller, as such recordings are carried out by BolognaFiere within the scope of its institutional purposes. Any refusal on your part would make it impossible for BolognaFiere to provide the requested service. Any specific photographs or recordings will instead be carried out by BolognaFiere only following your consent, which may be requested together with an appropriate information notice and a release form.

3. Methods of processing personal data

Personal data will be processed using paper-based, electronic and/or telematic tools, according to logic strictly related to the purposes indicated above and, in any case, in such a way as to ensure the security and confidentiality of the data.

Please note that BolognaFiere does not process your data for the purpose of making decisions based solely on automated processing that produce legal effects or significantly affect you, pursuant to Article 22 of the Regulation.

4. Recipients, categories of recipients of personal data and transfer of data to third countries

Your personal data may be accessed by shareholders, members of the Board of Directors or other administrative bodies and, in any case, by the Data Protection Officer, external Data Processors, persons in charge of processing and/or authorized personnel appointed by BolognaFiere in the performance of their duties.

Your personal data may be disclosed to parties providing BolognaFiere with services or activities instrumental to the purposes indicated above, including, by way of example, parent companies, subsidiaries, affiliated companies and/or joint ventures, entities managing and/or participating in the management and maintenance of websites and electronic and/or telematic tools used by us, photographers and/or videomakers providing documentation and event management services (e.g. installation of fittings and equipment, publishers of printed and online catalogues, logistics, security, surveillance, first aid, hostesses, etc.), diplomatic representations, consultants, law firms, banks, marketing and communication service providers; other parties involved in the management of selection procedures and related benefits for buyers (such as insurance companies, travel agencies, hotels, etc.).

Your personal data may be communicated and/or transferred abroad, in compliance with applicable legislation (Articles 45 et seq. of the Regulation), including to non-EU countries where the recipients mentioned above are located. In such cases, the transfer is necessary for the performance of a contract with the data subject or for the implementation of pre-contractual measures taken at the data subject's request, or for the establishment, exercise or defence of legal claims; generally, it is carried out on the basis of an adequacy decision of the European Commission (Article 45 GDPR) or in accordance with standard data protection clauses or other appropriate safeguards pursuant to Articles 46 or 49 GDPR. Where no adequacy decision has been adopted and no other safeguards apply, the communication and/or transfer of data outside the European Union will be subject to your consent, after having been informed that the country concerned does not ensure an adequate level of data protection.

5. Data retention

The personal data you provide will be processed only for the time strictly necessary to achieve the purposes described above, without prejudice to additional retention periods related to specific conditions of lawfulness of the processing (e.g. 10 years for the exercise of legal defence rights).

6. Data subject's rights

As a data subject, you may exercise the rights provided for under Articles 7 and 15–22 of the GDPR, within the limits and under the conditions set out therein. To exercise these rights, please contact the Data Controller at the email address privacy@bolognafiere.it, to which an appropriate and timely response will be provided.

In particular, you have the right to:

- obtain confirmation as to whether or not personal data concerning you are being processed;
- where processing is ongoing, obtain access to the personal data and information relating to the processing, and request a copy of the personal data;
- obtain rectification of inaccurate personal data and completion of incomplete personal data;
- obtain, where the conditions set out in Article 17 GDPR are met, the erasure of personal data concerning you;
- obtain, in the cases provided for by Article 18 GDPR, restriction of processing;
- receive the personal data concerning you in a structured, commonly used and machine-readable format and request their transmission to another controller, where technically feasible.

You also have the right to object at any time to the processing of your personal data carried out for the purposes of a legitimate interest of the Data Controller. In the event of objection, your data will no longer be processed, unless there are legitimate grounds for processing which override your interests, rights and freedoms, or for the establishment, exercise or defence of legal claims.
